A few comments regarding the poor sound and some of the speakers needed a lapel microphone. One of the speakers suggested having a clock more visible to ensure that no speakers overran. Overall the venue is free and only the catering needs to be paid for. JS will raise issues regarding the sound system and possible use of lapel and roving microphones if we are to hold this event at Chesterfield in 2015.

The decision to hold this event again at Chesterfield was discussed in depth and all the RTT members agreed it was a good idea to do, bearing in mind the RTC budget may also be reduced in the next financial year.

The next Training & Education meeting will be held on the 10th March 2013 and topics / speakers for the next annual symposium will be high on the agenda. The next education session for the RTC on the 2nd May 2014 will also be discussed and arranged.
