Reports were issued with the agenda for the working groups. Highlights for each group are listed below:-

4.1 Policies / Guidelines

Shared Care of Special Requirements

Update given by Jayne Addison:-

- The pilot between The Christie and Stockport was unsuccessful.
- Special requirements form has been placed on the RTC Website as a tool to use internally.

Special Requirements Key Fob

CMFT are piloting the issue of a special blood requirements key fob to patients. Mary Marsden, TP at CMFT gave a presentation and the main highlights are:-

- To issue patients with a special blood requirement key fob to alert health professionals who can contact their local transfusion laboratory.
- The local laboratory can then contact the Trust indicated on the key fob.
- The fob will be issued with an accompanying letter and verbal explanation given to the patient.
- A letter will be circulated to all North West Laboratory Managers and Transfusion Practitioners prior to the commencement of issue.
- On issue the information will be placed on to Medisec.

Regional Apheresis Roadmap

Presentation by Kate Pendry. Highlights:-

- Survey of current service provision sent to over 250 clinicians in the Region (North West & North Wales)
- 30% response rate so far, improvement in response is being escalated (targeted phone calls, letters to Chief Operating Officers)
- Action plan for service improvement will be developed in May 2013.

Massive Haemorrhage Toolkit

Presentation by Kate Pendry. Highlights:-

- Follow up meeting convened Friday 24th May 2013 at Manchester Blood Centre to:-
 - Update toolkit
 - Develop key performances indicators
 - Review audit process

Pre op Anaemia Working Group

New group to be launched. Aim is to produce a toolkit that can support the development of pre operative anaemia management services. 1st meeting is on Monday 17th June 2013 at Liverpool Blood Centre.

TEG / ROTEM

Presentation by Kate Pendry. Highlights:-
