- New software has been installed in the BacTAlert system which should further reduce the rate of false positives
- Customer Services are aware of problems associated with the recall process and are working with relevant leads to improve the process and paperwork

#### North West Regional Transfer Policy

- 7 members have expressed an interest in reviewing the document
- Needs to be progressed as soon as possible in light of updated national guidance and pressures of new vascular networks
