Constraints/concerns	<ul> <li>Some hospitals within the region have raised concerns regarding the new transport boxes from NHSBT and the communication process that was involved to inform them about their use.</li> <li>Many London Hospitals will be affected operationally during the Olympic period, the delay in NHSBT's plans and stand are causing concerns and delays in hospital planning during this period.</li> </ul>
Administrative support for the RTC	Susan Wood 20 hours per week, based at NHSBT Colindale
Other issues	Use of audience response systems has proved to be beneficial at RTC events within region. Their use has been very popular with the delegates. The system used has been loaned from a hospital within the South East Coast Region, however would be an advantage to have these systems available at all times for use in all RTC education events.
