
# West Midland RTC Cell Salvage Support Group

## 1. Present, Apologies and Welcome – Falguni Choksey:

## 2. Minutes and actions from previous meeting – 25 September 2015:

Actions to be carried forward as follows:-

- Expressions of Interest to join the UKCSAG are being sought. Andrea Harris had been tasked with sending FC/MC details to the above. Action: Suzy will find out if this has been action as FC/MC had not heard anything to date.
- Cell Salvage scenarios to be written for the RTC website. It had been agreed they were a good training and competency assessment tool, but they needed to written especially for the RTC website, as it is not interactive. Andrea Harris had been tasked with raising this at the next RTT/RTC. Action: Falguni will speak to Dr Chris Newson about this and feedback.
- o Cell Salvage Awareness Campaign. To be discussed further at the meeting.

## 3. Local Cell Salvage Updates

Cell Salvage Awareness Campaign - discussed as follows:-

- FC had produced some discussion notes on projector screen so that the group could read and make alterations with immediate effect.
- $\circ\;$  It was agreed that the assistance and coordination of the TPs in each hospital, would be required.
- It would be very useful to get this published in any "Anaesthetist's Journal", It will be forwarded to UKCSAG

## • Action: Falguni to contact and find out process for publishing.

- Stefan (SATHT) thought Board members should be made aware.
- Nikki (RJAHT) thought their nurses would benefit from training on this. Both will share thoughts and ideas going forward.
- A leaflet will be given to patients.

Action: Matthew will send information regarding icons?

Action: Nikki will attach this to her training programmes.

#### Action: Suzy to find out if we have blood transfusion awareness on twitter?

• The launch date is 14 June (giving us 2 months to produce it).

- Action: All comments back by end July.
- There will be a sample size of 50.
- TPs and haematology need to be involved.

#### Cell Salvage Training for Surgeons Question:-

Stefan (SATHT) asked the group on behalf of Catherine Stewart about what other trusts do with surgeons, ie. "do they receive specialist cell salvage training, provided annually and signed off"? Comments were as follows:-

- UHB do a pre-op discussion and provide labels for the Anaesetists chart and are then signed off. MC reported that UHB are doing awareness for patient (governance, research and evidenced based).
- Each trust needs a Cell Salvage policy on intranet for ease of reference.
- Group agreed that there is no need for the consent from surgeon or Anaesthetist to be signed

Action: Stefan to feedback to his trust that there was no standard for this.

#### 4. Cell Salvage with Tumour Cases – Request from Surgeons

Nikki reported that there are issues with surgeons using Cell Salvage on patients with tumours. Comments feedback was as follows:-

- o Consider risk benefit ratio individually.
- Consider effects of allogenic blood transfusion- attributed to TRIM (transfusion induced immune modulation) poor outcomes like increase post operative infections, wound complications, pulmonary and renal complications increased mortality,
- Higher rates of recurrence especially in colorectal and urological surgery have been associated with allogenic transfusion.
- In vitro work has shown that leucocyte depletion filters are very effective in removing the malignant cells. There is evidence that operative manipulation of the tumour during surgery leads to peripheral blood concentrations of malignant cells many times higher than could be attained with cell salvage alone, The presence of circulating tumour cells is prevalent in cancer surgery but is not associated with survival, and it has been suggested that circulating tumour cells with the potential to form metastatic lesions are rare.
- o **Isolate tumour**.
- o Undertake an audit of other patients over a period of time

Action: Nikki to ask RoH (Chandra B) and BCH (Clare P) what they do.

*Cell Salvage Group UK – HoTSIG –* stands for Hospital Transfusion Special Interest Group – the group discussed about presenting at a future session – and if this was a good way of communicating.

Action: Falguni to consider on behalf of the group.
