4. Patient Blood Management:

AS presented as below: -

- Red Cell Issues mapping and platelets sheet was shown.
- A toolkit and Algorithm / guidelines for Pre-op anaemia in primary care is presently being piloted in the East of England. AS will keep the committee informed on progress
- Irradiated labels Remains in the Validation process. Resources will be available to hospitals to help implementation. Hard copies will be sent through the post to TPs and TLM (Screen savers and A5 flyers)
- The 'Pre-assessment' checking process video shown to the committee

7. Updates and Issues from Regional Groups:

A - Transfusion Practitioners

MB reported to the committee on behalf of the TP group

TP Regional Group – the first telecon had been successfully held with one of its aims to share information. This will now be held via telecon going forward. Ant Jackson is the BBTS TP representative and also sits on the NBTC. He has agreed to act as a liaison between the TP regional chairs and BBTS/NBTC. He will also explore the feasibility/funding of an annual face to face meeting for regional TP chairs

- MB had agreed to circulate the electronic shared cared document to the other regional TP Chairs.
- Following an MHRA inspection in East Midlands the inspector had raised the question of TP training/competency evidence. The group expressed that there is no formal training document AJ agreed to share the competency they developed as a starting point for other regions to explore

C Cell Salvage Group

FC and AS reported to the committee on behalf of the CSA group

- WM Cell Salvage support group: meets twice a year next on Monday 10 September 2018 (2019 dates are as follows - Friday 29 March and Wednesday 18 September) – held at Birmingham New Street offices. They provide support and networking opportunities to the Cell Salvage leads and coordinators re education, training and governance issues.
- 2 Regional Surveys 1. perception of public visiting the hospital regarding cell salvage; and 2. survey of staff working in the hospital regarding their knowledge of Cell salvage. This will be available soon.

- the usage in hospitals have decreased as surgical operations have changed for example in vascular many cases are done with interventional radiology as EVVAR instead of open AAA repair.
- The SALVO trial publication has impeded implementation of cell salvage in obstetrics in some hospitals of the region. though there have been challenges to the conclusions drawn in that study (CS should not be used in every case) and concerns raised regarding the methodology used. Many hospitals that were already using cell salvage in the country have not changed their practice,
- UKCSAG Education Workbook has been reviewed and new version is available via their website to download. The information leaflets are being reviewed and will be uploaded shortly.
- BBTS: considering presentation in the annual conference?

08. Competency Data Issues/Cathy Lim Updates:

CL reported to the committee on behalf of the NHSBT group

- NHSBT (New) Irradiated Labels CL informed the group of the changes to the these have now been delayed. CL will inform the group when further information about labels is available.
- OBOS online errors CL reported that had recently had ordering issues for some hospitals, particularly with ordering in the early hours. CL said this is currently being rectified and further information will follow about progress updates.
- OBOS receipting CL said that you should soon be able to put exact time on these. Further details will follow.
- The recent CO2 shortage had not affected NHSBT overall.
- NHSBT have a Methylene Blue and Cryo shortage CL reported that, therefore, can hospitals and trusts' order rhesus negative instead.
