8. Issues from Hospital Transfusion Teams

8.1 Summary of points raised by HTC's

- No hospitals have a conservation lead
- Financial constraints / staffing resources
- Availability of HAS
- Lack of attendance at HTC meetings
- Unsupervised locum staff



Lack of trained staff

NPSA and competencies. Action: GS will ask at the meeting with MHRA to see if they can provide a more definite answer regarding whether assessments should be carried out every two or three years.

Calderdale & Huddersfield – TP covering nursing duties losing 20% of time, resulting in less time dedicated for TP role. TP also at Mid York's has been asked to work in A&E due to nursing background. Action: YS to raise at NBTC.

Leeds Teaching - business case in progress for pre-operative anaemia clinic.

We need to find a national solution to the shortage of Albumin. Action: YS to discuss this with GB at DCR as not aware of this problem.

Anti D stocks - shortage with BPL . Action: YS to raise at NBTC.

Mid York's – Questioned if any other trusts have implemented a scorecard as per the PBM recommendations and if so could anyone advise what impact this has made.

8.2 TTP case

Report following a SUI/SIRI; patient with TTP. One of the action points was to bring to the RTC with regards to the treatment. Trust has not had a TTP patient for 14 years.

Key points discussed:

- No stock of Octaplas at the time of case but now stock 80 bags
- Lack of recommendations around transfusion in TTP cases
- Octapharma will be tracking all orders
- Guidelines unclear re the use of FFP and request now processed via Dr Massey BSCH guidelines now revised and published
- MK has been approached to do a survey on treatment for TTP will send survey to YS and then circulate in region
- Support from RTC to try and improve the service of TTP patients
- Review of stockholding

9. NPSA competency assessments
