### 1. Welcome & Apologies

YS welcomed everyone to the meeting and apologies were noted.

### 2. Minutes of the last RTT Meeting held on 27<sup>th</sup> February 2013 and matters arising

The circulated Minutes (Paper 1) were accepted as a true record and will be placed on the website as "Confirmed".

Not everyone has used the new updated HTC form which asks whether their trust has any action plans set up regarding the use of platelets therefore this needs to be highlighted when sent prior to the next RTC meeting.

### 3. Y&H RTC Budget

#### 3.1 Report and review of commitments (*Paper 2*)

OC went through Paper 2 and confirmed that only a small balance remained outstanding at the end of the financial year 2012-13. We received £1,117 in sponsorship and our total expenditure was £4,966. Next year's budget will be the same at £3980 and if anyone has any ideas / suggestion we can review to see if we have enough funds for any regional / educational projects.

### 4. Regional Educational Activities

#### 4.1 Educational Activities

- **Patient Blood Management – 25/04/2013, The Source, Sheffield – feedback**

This was held jointly with the East Midlands RTC. AD confirmed overall this event was rated with a top box score of 97%. There were 42 delegates of whom 33 were from the Y&H region.

- **10.06.2013 – Nurse Authorisation Day**

This will be run by the TP's/AD from the region and the other date will be on 20<sup>th</sup> November 2013 both held at the Leeds Blood Centre. The North East are not running their course this year therefore we could open up some places for their nurses to attend. All speakers are now confirmed.

- **RTC Annual Study Day 30/09/2013 – "A Bleeding Crisis", Pinderfields Hospital**

We are planning to advertise this over the next few weeks and already we have received interest from delegates and hoping to have 4 sponsors on the day.

The TP group have also shown interest in development and education days' i.e. business cases & MHRA.

### 4.2 Audit Working Group update

Data collection ended 31<sup>st</sup> March 2013 and Brian Hockley is now analysing the data. We are hoping to produce the results later in the year along with a poster. Any further ideas welcome for the next audit for 2014.

### 8. Use of blood in the region

Issues / concerns regarding the age of blood issued from NHSBT and whether they can at least provide a mixture of expiry dates. Again it was highlighted that you can specify the age of blood on OBOS.

It was discussed why the demand for Red Cells has somewhat declined over the past few months and this will be closely monitored. RG advised their issues have reduced however their activities have increased therefore no explanation as to why this has occurred.

Ongoing problem with trying to book donor sessions – not enough appointments available.

### 9. Issues from Hospital Transfusion Teams

#### 9.1 Summary of points raised by HTC's

Action: OC to change proforma to replace Better Blood Transfusion to Patient Blood Management

Steady progress with PBM.

Only one hospital declared having a blood conservation lead. We cannot engage a working group. The best group to target will be vascular surgeons / anaesthetists.

Mid Yorks – New pilot at looking at transfusion in the community, targeting IV therapy nurses. CB has researched this area and received good policies.

Other main concerns from hospitals:

- Training restraints
- Low moral amongst staff
- Lack of attendance at HTC/RTC meetings

#### 9.2 Round table discussion

- Discussion regarding sharing information on SpICE.
- Issues regarding ESR; e-learning packages and learnbloodtransfusion. New competency assessments document to replace NPSA 14 Right Blood Right Patient is being drawn up and should be available imminently.
- The issue of fresher blood from NHSBT – the age of blood can be requested via OBOS.
- Ageing population of TP's. This group is depleting due to retirement and this will cause delays in replacements and cover for some hospitals.
