1. Welcome & Apologies

YS welcomed all to his first RTT meeting and although YS doesn't know everyone he will be looking forward to meeting the team as the new RTC Chair. Apologies were noted.

4. Update from RTC Chairs and NBTC Meetings - 24.09.2012 (Paper 3)

YS confirmed he was unable to attend this meeting due to short notice of being elected just prior to this. Therefore the report below is from the East Midlands RTC Chair for perusal.





SSh added that Mid Yorkshire Trust is no longer using FFP and only use Octaplas.

AD confirmed the Patient ID campaign – "Do you know who I am?" has been launched this week and OC will circulate the link for resources / posters / leaflets etc to be used in all hospitals.

GS confirmed that he attended the National Laboratory Managers Meeting and the key point discussed in length was pathology modernisation, quality of staff and the new transport boxes. The next meeting is scheduled for early 2013 and GS is hoping to attend.

AD confirmed all TP's now have the 'Framework for Development' document and the course that is held at Newcastle maybe rolled out nationally.

AIM II Trial – 4 trusts in the UK are participating and the key purpose of this trial is to see "where blood is going".

SaBTO have advised there are no requirements for written consent, however there is a current debate around elective surgery that do not need to be transfused.

HTC Chair survey – AD confirmed poor response from the Y&H region. YS confirmed the main issues appear to be lack of attendance to RTC meetings.

AD advised there is an extensive liver audit being carried out by Simon Stanworth, South Central RTC. There are results available following the South West RTC audit on platelets.

5.1 Education Activities

Patient Blood Management - 25.04.2013

This is being held at 'The Source' Sheffield jointly with the East Midlands RTC. This is to mirror the recent event held in London where Sir Bruce Keogh and Linda Hamlyn attended. TI attending this on behalf of our region.

5.2 Regional projects

• Y&H Competencies Project

This has now been rolled out and the benefits will not be seen until August 2013 when the junior doctor's rotate to different trusts.

All the documents have been ratified and are on the website. Trusts can use these templates and add their own logos. There are 3 delegates registered on the North West RTC course in November 2012.

5.3 Audit Working Group

AD - There are plans to roll out a massive haemorrhage audit in our region in January 2013. The final draft of the audit proforma is underway along with all the appropriate letters to the Caldicott Guardians etc.

East Midlands are also keen to roll out this audit for comparison data.

5.4 Platelet action group (Paper 4)

AD confirmed this is a re-occurring theme and being brought up in various meetings and action groups.

SSh confirmed Mid Yorkshire Trust are doing their own local audit and will be aiming to do this every 12 months. They are using the NCA tool as their base for their audit proforma.

AD suggested asking all HTC's / hospitals what action plans they have in place and feel that this would be more beneficial than having a platelet action group.

YS advised Doncaster may look again to re-audit platelets.

6. Blood Conservation Lead

AD confirmed this is a requirement from the NBTC and all trust really should have one. If the Y&H have a blood conservation lead this person should then ideally be the chair of a sub group from the RTC with members who are interested in cell salvage etc.

SS added that she is unable to take on this role and there is nobody else at York. YS has a colleague at Doncaster but he is very much likely to decline due to work pressures.
