Afternoon Committee Meeting:

Review of previous minutes and actions:

The circulated Minutes (Paper 1) were accepted as a true record and will be placed on the website as "Confirmed". Actions were reviewed and all actions have been completed or are on the agenda. The acronym EM was explained as referring to East Midlands (RTC)

AOB and issues raised from the floor:

- SM; welcomed Jennifer and Sharon to the group. Fran Hartley is returning to work on 8th July (SM on AL). Fran has commented that up to date material re the transferability project is not on the RTC website; AMD requested that Fran sends her what she wants uploading on to the site. SM also raised the suggestion of a joint meeting with EM TP's; this was agreed. Suggestions for venues, topics and speakers were requested (risk management, behaviour change examples)
- TI; asked what other Trusts are doing regarding converting to Octaplas from MB FFP there is great variation. Some Trusts are using Octaplas when adult volumes are required and normal FFP is not suitable but continuing with MB FFP otherwise. A regional tool for prescribing guidance based on NBTC indications was suggested; JR LTH agreed to lead this work
- TT; to meet MHRA/NPSA/CPA standards in relation to component collection they are considering MLA's "handing over" components
- JR LTH; explained how Marina Karakantza is reviewing Transfusion training for haematology SpRs
- SN; expressed thanks for the warm welcome she had received
- CB; discussed their intention to introduce OSCE style assessment for the entire sample process including venepuncture and infection control as well as sample labelling and patient identification. SM and JR STH described similar approaches. Plans to use erostering to support training and competency assessments were discussed and how it allows ward/department management plus accurate statistics
- RH; storage of "flying squad" paedi-packs discussed; Barnsley have decided not to have them available in the issue fridge but in lab fridge ready for immediate release on request. Some trust just make available an adult unit of appropriate spec for neonates
- JR STH; requested contact numbers for the day are included in the agenda
